We refer to and reiterate our previous statements on the topic, particularly our
statement in which we proposed, as regards draft article 12 (formerly draft article, 11)
to include the phrase ³ Z L W K W K H F R Q V H Q W R I W K H 6 W D W H R I I L F

We also recall supporting the view of deleting the fifth paragraph of draft article
12 (formerly draft article 11), which states that waiver of immunity is irrevocable
on the grounds that neither relevant treaties nor domestic laws of States have expressly
referred to the irrevocability of waivers of immunity and that practice on this issue is
limited.

We took note of the decision of the Commission to transmit the draft articles to Governments for comments and observations, and to submit further comments on the draft articles and commentaries therein as necessary.
