Parties' Submissions

- 18. According to the Respondent, this application before the Tribunal is therefore time-barred.
- 19. The Respondent makes the further argument that the application should be dismissed for want of merit because the decision to abolish the post encumbered by the Applicant was lawful. Vj g''Crrrlecpvu''ercko "vj cv'j g''y cu''r reegf "qp''ur geken'rgexg'' with full pay is incorrect and there was no *de facto* termination on 16 May 2020.

Considerations

Receivability

20. Vj g"Tgur qpf gpvxu"uwdo kuukqpu"qp"tgegkxcdkrkv{ reflect a misunderstanding of the impugned decision being challenged in this case. The Tribunal finds that the Applicant has clearly articulated his grievance. He is not challenging the abolition of his post.
